

BOND JUMPING THING OF PAST IN COOK COUNTY

None Defaults in a Year; Only 17 Since 1932.

Not one bond forfeiture has occurred in the Criminal court since April 7, 1937.

Another improvement is revealed by the report of Judge Harrington, who will relinquish the stewardship of the court on Labor day to his successor, Judge Michael L. McKinley.

It is the speedy trial of criminal cases. Ninety per cent of these cases are now being tried within thirty days of indictment and only 136 are pending.

Old Type Bondsman Extinct. Professional bondsmen, who in former years would schedule anything from a street car to the blue sky, are a thing of the past in the Criminal court, said Assistant State's Attorney Melvin Remble in charge of bonds.

In the six year period since 1932 only seventeen defendants have escaped punishment by the bond forfeiture rule, according to Remble. Although 132 defendants attempted to escape by forfeiting bonds, all were arrested except the seventeen now at large.

The improvement in the bond situation started in 1930 when former State's Attorney John Swanson in cooperation with the Chicago crime commission, then an aggressive crime fighting unit, started a drive to collect on forfeited bonds under newly passed laws.

Courtney Keeps Up Fight. State's Attorney Courtney has carried on the fight since 1932. His bond department has the cooperation of the Criminal court judges.

The vivid contrast between the past and the present is illustrated by the year to year table following [comparable figures for 1931 and 1932 are not available because of a change in the bookkeeping method].

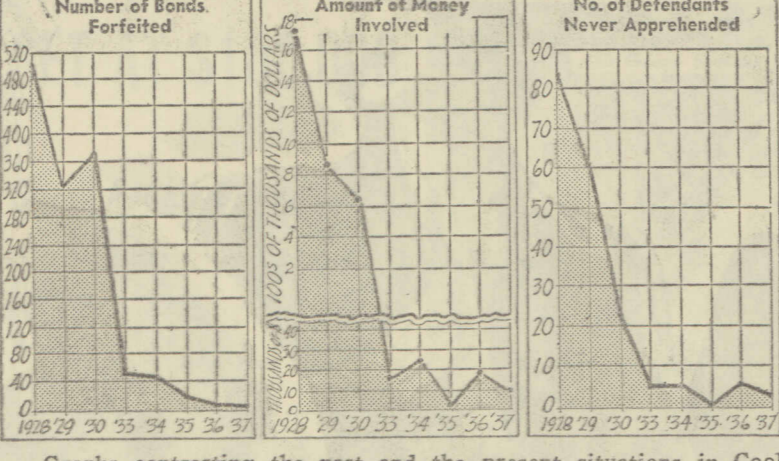

So far this year the bond department has accepted 257 bonds without a forfeiture.

Property involved in forfeited bonds since Courtney took office has reverted to the county under sheriff's deeds and cannot be sold or mortgaged by the owners until settlement on the bond has been made with the county board and the property released.

Can't Pay Lawyers, He Tells Court.

Sarasota, Fla., July 23.—[Special.]—Potter D'Orsay Palmer, scion of the Chicago Palmers, is broke and has no means of paying alimony and counsel fees to Pauline Warren Palmer, his wife of a year who is suing him for divorce, according to objections filed in Circuit court here today.

Palmer generally has been supposed to have an income of several thousand dollars per month, so the statement of his attorneys that he was without means to provide for his estranged wife came as a surprise.

D'Orsay, who is 32 years old, 6 feet 3 inches tall, the son of Honore Palmer, has been married three times. He has made liberal financial settlements upon two former wives.

His first wife, Eleanor Goldsmith, 36 years old, a golden haired school girl, was divorced ten years ago. It is said he has completed a series of substantial annual payments to her under the divorce settlement.

A speeding automobile plunged through a wooden guard rail last night and fell thirty feet into the yards of the North Western railroad near Union avenue and Erie street.

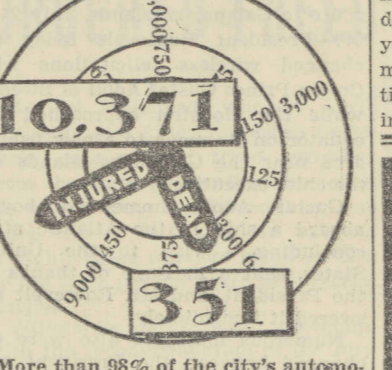
