Education & Assistance Programs for Michigan's Forest Landowners

INTRODUCTION

Forest landowners have access to several sources of information to assist them in understanding and managing their forest properties. These include both public agencies and private firms. Whatever your situation as a forest landowner there is probably an organization that can help.

Public organizations that provide information and assistance relating to forestry include the Cooperative Extension Service, the Forest Management Division of the Michigan Department of Natural Resources, the Soil Conservation Service and local county Soil and Water Conservation Districts. Limited financial assistance for some forestry practices is available through the Agricultural Stabilization and Conservation Service. Assistance from private resources is provided by forest industries and individual forestry consultants.

This publication provides a brief description and explanation of each of these information sources, including current addresses and telephone numbers. For more detailed information, contact your local county Cooperative Extension Service office or the respective organization. County Extension agents also have easy access to the specialists located on the Michigan State University campus.

Information & Educational Programs in Forestry

The Cooperative Extension Service (CES) is a partnership of the U.S. Department of Agriculture, Michigan State University and county governments. Its purpose is to provide up-to-date and understandable information related to a wide variety of subjects in the agriculture and natural resource areas. CES plans and conducts educational programs related to agriculture and natural resources and makes available no cost or low cost publications related to many aspects of these same two areas. Each county in the state has an Extension office that you can contact for information on upcoming educational programs and a listing of available publications. County Extension agents also have ready access to the specialists located on the Michigan State University campus.

Forestry Extension typically offers educational programs relating to woodlot management, wood production, Christmas tree management and timber business-taxation considerations. The Cooperative Extension Service also offers a wide range of publications that provide information on forest management, forest insect and disease problems, tree planting, herbicide use, species selections for Christmas tree plantations and similar topics.

Technical Assistance Programs Available from Public Agencies

Forest Management Division
Department of Natural Resources

The Forest Management Division of the Department of Natural Resources offers limited free technical assistance to forest landowners. Recommendations for harvesting and timberstand improvement and the writing of forest management plans are the two major activities emphasized by the Cooperative Forest Management (CFM) program of the DNR. A management plan lists the landowner's objectives and outlines the steps necessary to meet these objectives.

Although the implementation of the forest management plan is beyond the scope of the CFM program, the DNR forester is a good source of information on where to look for assistance for implementation. Assistance in selecting trees for harvest and in marketing forest crops is also provided.

Soil and Water Conservation Districts

Soil and Water Conservation Districts (SWCD) have been established throughout the state to assist Michigan landowners in land-use planning. In the past this has been associated largely with agriculture; however, several conservation districts in Michigan employ professional foresters. The SWCD foresters provide, upon request, information and services related to both tree planting and woodlot management to landowners in their district. A staff forester with the Department of Natural Resources provides technical assistance to SWCD foresters when required.

Financial Assistance from Public Sources

Agricultural Stabilization and Conservation Service (ASCS)

The ASCS administers two cost-sharing programs designed to encourage the conservation of forestland resources and assure future productivity. The Forest Incentives Program (FIP) and Agricultural Conservation Program (ACP) can offset up to 75 percent of the landowner's total costs for tree planting or timber stand improvement.

The local ASCS committee determines which of these forestry practices are to be funded and is responsible for distributing funds. Applications are necessary prior to initiating any work. A forester from the Department of Natural Resources will visit the site to certify that the work is necessary and to estimate the cost of completing the projects.

All Michigan counties are eligible for ACP cost-share program funds, and 42 counties are eligible for FIP cost-share program funds. Contact the ASCS office in your county for more information.

The consultant's reputation is his best calling card, so they work hard to satisfy their clients' needs. However, when selecting a consulting forester require and check references before hiring one.

Industrial Forestry Programs

Some forest product companies in Michigan provide technical assistance to landowners interested in managing their woodlots. The type of programs available vary among the companies, but most offer forest management planning at no direct cost to the landowner. The only payback requirement in many of the programs is that the company requests to be notified when the decision to sell the timber is made. Some programs require the landowner to provide the company with the right of first refusal.

Other forest products companies operating in Michigan do not have a formal assistance program but employ professional foresters who may be able to provide recommendations concerning woodlot management. It may be wise to visit with landowners who have had previous experience with such companies.

These "Pioneer Tree Farms" are inspected and certified at no cost by a volunteer forester representing the Tree Farm Program.
