

Five Injured in Accident at M-52/Austin Intersection

A crash which could have been much worse, hospitalized five victims from two vehicles on Friday, February 7.

A 1985 Dodge van, carrying four passengers, was east bound on Austin Road, and a 1997 Dodge Intrepid was making a left from northbound M 52 toward City Rd. when the collision occurred.

The van hit the Intrepid broadside, sending the car into the ditch and causing the van to do a 180-degree turn on Austin Road. Fortunately, no life-threatening injuries occurred.

The police report shows that no illegal substances or alcohol were involved in the accident. The driver of the Intrepid was from Georgia, and the car was rented. Unfamiliarity with the intersection, and with the area could have contributed to the accident. The driver was ticketed for a hazardous violation - failing to yield right of way. He stopped, didn't see the van, and pulled out. No high speeds were involved; the van braked prior to collision but couldn't avoid hitting the Intrepid.



Shakespeare Club Celebrates 100th Anniversary

The Shakespeare Club was organized in February, 1897 to "gain knowledge of the works of Shakespeare; to become familiar with other literature and history; and to foster a broader culture through interchange of thought," and for one hundred years they have continued to follow in the footsteps of their predecessors.

Originally there were eight members of the Shakespeare Club and among the list of charter members are some very familiar names to those knowledgeable about Manchester's history. Emma J. Goodyear; Florence W. Case; Annetta English; Florence A. Russell; Lucelia M. Case; Fannie Lewis; Emma A. Rowe; and Dillie S. Hall.

At each current meeting, in celebration of their 100th year, according to member Jane Korth, the minutes of the previous meeting are read, and then the secretary shares the minutes of some of the early days of the organization. "One difference we notice is that they were much more formal back then," muses Jane. "The members are all referred to as 'Miss' or 'Mrs.,' and the language of the minutes is quite different from what we're used to today."

But still, today's members remain true to the original purposes of the Shakespeare Club. "We do study the works of Shakespeare, but we don't confine ourselves to just that," Jane explains. "We also study other books and topics of general interest." They limit their membership to a small number (currently there are twelve members) so that they may continue to meet in members' homes, and "we don't serve refreshments, which makes it easier to find hostesses!" she adds with a smile.

The group will take a departure from this tradition this coming Saturday, February 15, where as part of the cel-

ebration of their anniversary and in conjunction with the winter festival, they will hostess a reception at Chapters and Verses, with refreshments and conversation provided by the members of the Shakespeare Club. If you've passed by the windows of Chapters and Verses this week, you have probably noticed the display set up in the window with a list of all the members since 1897, along with an assortment of Shakespeare books. At their inside display this Saturday, they will also exhibit historic documents relating to the club, an assortment of yearly program books, and a photo album of members past and present.

A 1957 edition of the Manchester Enterprise is among the displayed items, and at that time it is noted that the Shakespeare Club, at 60, was the second oldest women's organization in the county. They believe they are still the "second-oldest," which is still quite a distinction 40 years later, as they begin their second century of reading and studying the various works of Shakespeare and other authors.

As always, the meetings

are held from 1-3 PM, twice a month, and the same agenda is maintained as it was begun 100 years ago. The reasons for the meeting time and strict adherence to the agenda, may be slightly different today than in 1897, however. At that time, in the constitution of the group, it was noted that the meetings would adjourn promptly at 3 PM to allow the members to return home in time to fix dinner for their husbands and families. The agenda includes a brief business meeting, the program topic, and a discussion of current events, all of which occur pretty much on schedule.

The "senior members" of the group in 1997 are Margaret Kulenkamp, Jeannette Kirk, and Wilma Bucholtz. These ladies have been members of the Shakespeare Club for many years (and no one is willing to venture a guess as to how long.) But the ages of the members are as varied as their reasons for joining. "We have a wide range of ages, from a young woman with a new baby, to some of our 'senior' members who are in their eighties," says Jane Korth. She has been a part of the group since 1976, but left during a time when she

worked for ten years; re-joining in 1989. She enjoys the "intellectual stimulation" that the bi-weekly meetings provide her.


Another member, Shirley Carpenter, says, "I've done a lot of things, and read a lot of books, that I probably wouldn't have had the oppor-

tunity or inclination to otherwise." She talked about an upcoming trip to see a theatre production of "As You Like It," in Tecumseh, an event to which she is looking forward.

All the members are excited about their celebration this weekend, too. They hope many community members will stop in to Chapters and Verses on Saturday to chat, to browse, and to familiarize themselves with another aspect of Manchester history which fascinates so many. "Siobhan and Edna have been very helpful," says Jane, "and we hope that this will be a successful event for them as well as for us."

As you're browsing through downtown this Saturday visiting the merchants who celebrate Winter Festival in the Village, make sure Chapters and Verses is on your list of places to stop. You can look forward to receiving some "intellectual stimulation," too. It's the specialty of the Shakespeare Club.

It is bad enough that our children when sitting in their seats have these edges that are even with their heads. But when an injury doesn't even get looked at that is a problem. Students should not have to explain to their parents why their head is bleeding from the bus ride

This has the potential to turn into a big problem. Just wait until a more serious injury oc-

Wreck



Dear Manchester residents,

I would like to respond to the recent article and editorial regarding the breakfast pro-

Recently many people have asked me, "What is going on with the breakfast program?" I am thankful there are still people out there who want the acts instead of making judgments or assumptions.

As may of you already know, at the end of this year the Board will have to decide if we're going to keep and promote this program or discard it. As I prepare for this, I have to look at all the concerns that have surfaced.

- 1) Bus Schedules: Will we gain 15 minutes?
- 2) Discrimination: Are there students at Klager and Middle Schools braving the poor weather conditions begging to get into the schools?
- 3) Money: Are we losing hundreds or thousands of dollars?
- 4) Participation: Are there "under a dozen" or exactly "17" students total utilizing this program?
- #1 Our bus routes have increased in size since the beginning of the breakfast program. Because of this we may gain five minutes on a few bus runs. I have asked the Transportation Department to prepare updated schedules for review.
- #2 You can find me quite often at the Middle School between 8:15 and 8:40 AM. It's true there are a lot of kids on the

playground, very few have their heads hung low or are visibly upset about being outside. Most are playing basketball, foursquare, walking "the square" or in groups talking. When the bell rings many have to be told (more than once) to go inside! I'vè also seen many kids go in early to put away band equipment, special projects, use the bathroom or phone, etc.

#3 - According to the 95/96 numbers Klager made a profit of \$769.12, Middle a loss of \$422.07 and High School a loss of \$2116.46. We have discontinued breakfast at the High School as it was clear the students were not utilizing this program. Klager & Middle School combined shows a loss of \$347.05. We choose to follow these two schools and make our decision at the end of the school year. With the State reimbursing us for no-cost and low cost meals it's hard to say how the numbers will end up.

#4 - The two figures which have been stated in this paper are "below a dozen" and "exactly 17." Last Thursday at Middle School we had 16 students eating Breakfast. The numbers at Klager are higher. Until I have physically visited both programs (a number of times), I can't give exact num-

As I continue to gain accurate information I will continue to update my community.

I have some questions about the school breakfast program. Why was this issue voted upon at the January 27th school board meeting? I attended a board meeting before Christmas and when this issue was raised it was decided that it would be tabled until spring. Where does the funding for this program come from? If this money is not spent on the breakfast program what will happen to these funds? I think it is important to note that at the board meeting I attended in December it was established that the program is not operating in the red. Have bus pick up times really changed because of the program? Will they change if the program is discontinued? Why is there such a discrepancy in the number of children participating in the program? Should a program such as this be based on mere numbers?

I think it should be pointed out that children who do not have breakfast at school are not being punished as suggested by some. These children are playing and talking with friends while other children are eating. All children have the option of staying in if not to eat, to drink a juice or milk.

In a perfect world there would be two parent families eating and enjoying a nutritious breakfast together before the start of their day. In reality not all parents can be home in the mornings with their children and some are not financially able to provide for all their children's needs. Unfortunately there are possibly even some worse scenarios why children may not receive this traditional family breakfast time.

Let us not forget that research does support the fact that children can and do learn better and more readily if they eat nutritiously. Also they gain from a good emotional start to their day, which is provided to them by caring staff.

The point that a board member made of it being the schools responsibility to educate our children not to feed them. Well, where do we draw the line, with other services provided in the school setting? I will not be specific but there are several services that are costly to the taxpayers. The argument could be made that there is not a direct link to education and that these services are parental responsibilities.

Even if we are not mandated to provide a certain service for a child do we turn our back on a child if there is a need? I am sorry that some board members do not feel a responsibility to all children to provide for them what they need whenever it is possible, but I as well as other members of this community, parents and staff feel a responsibility to all children.

ENOUGH is all that I can think to describe the Juice/ Goldman fiasco covered in/on TV, radio, newspapers and tabloids. The massive costs incurred by law enforcement, prosecution and California court system, not to mention the time that was expended by individuals who served the jury system.

Whether we agree or disagree with the outcome of the first trial, (criminal) finding Juice not guilty (beyond a reasonable doubt) should not be questioned. A jury of his peers so decreed! The second jury's, civil trial decision, finding Juice guilty and liable to the extent of eight and a half million plus punitive damages yet to be determined, also is a matter of



I'm used to having Ludwicks take off for Florida each year and often "surprised" when the return- and hand me some Vidalia onions or fresh picked tomatoes. But Israel via London? Sure don't have any idea what kind of surprise they could bring back—maybe some rocks from the via Dolorosa or some kosher pork chops! Their stop in London reminds me of the following story which I wrote some years back:

In 1951 I traveled to London from my army station in Stuttgart, Germany. At that time the military situation was tense enough to make it necessary for us to be recalled promptly in the event of an emergency, so I needed an address on my leave orders. I asked a fellow officer who had served in London during World War II to give me the name of a hotel. He suggested the Hotel Coventry, but as things developed, I'm glad the army didn't need to reach me.

I left Stuttgart on an evening train headed for Ostend, Belgium, the port on the Continent serving a ferry to Dover, England. From Dover I took the train and arrived at London's Victoria Station, an unkempt cast iron relic from the more flamboyant railroad times in Britain. It was my first trip to London so I had to depend on a cab to get to my hotel.

I hailed one and was very surprised to see what responded to my call. The cab was ancient and built so the driver sat out in the open. My driver was bundled up against snowy March weather and at times had snowflakes melting on his ruddy face, shaggy eyebrows and mustache.

Passengers used the enclosed portion and a sliding glass window permitted conversation with the driver. After my bags were loaded and I was seated, the driver started the motor, slid the glass open and said, "Where to, Guvnuh?" The only hotel I knew in London was The Coventry so I asked to go there. He said, "Hm-umm" and closed the glass. We lurched away from the curb in a cloud of exhaust smoke, on the "wrong" side of the road with the meter ticking away and showing peculiar symbols like **d. 1-. and £.**

We had gone but a few blocks when the glass slid open and the driver inquired, "You're quite sure it's the Hotel Coventry?" I replied, "Yes," and he again said, "Hm-ummm," as he closed the glass. A bit farther on he asked whether I had reservations. When I told him I didn't, he again said only, "Hm-umm."

The thought passed my mind that I had a nosy cabbie, but the heavy traffic, left hand driving and the sights of the city made time pass quickly. As we slowed and turned a corner, the glass opened once 18: again and the driver said, "I don't think there is a Hotel Coventry; it was bombed out during the blitz." The end of the sentence coincided with our stop in front of a gaping hole in the ground where the hotel had once stood.

The nosy cabbie earned a second fare taking me to a hotel that was still standing. Sure hope Del and TV followed had better cabs in London lune and weren't taken in by a Cersharp cabbie.

Enough of my rambling and on to the events we need to be concerned with this week.







Olympian Visits MHS

Livonia's "Home-Grown" Olympic Swimmer Presents Motivational Message



Sheila Taormina, 27, a lifelong resident of Livonia, competed in Atlanta at the Centennial Olympic Games on July 25, 1996 as a member of the U.S. Swim Team. Sheila swam the third leg in the 800 Free Relay and won a gold medal.

At Stevenson High School (1 987), Sheila was a 4.0 student throughout her Livonia academic years. In her senior year at Stevenson, at the Michigan High School Class A State Swimming Championships, she set State records in the 200 vard Individual Medley and the 100 yard butterfly and helped her re set a record in the 400 yard Free Relay. The Michigan Coaches Association voted her the 1986 - 87 Michigan High School Swimmer of the Year award.

Her college years were spent at the University of Georgia where she received a full swimming scholarship. She graduated Magna Cum Laude (G.P.A. 3.8) in 1992.

During her four years of

undergraduate work at Georgia, she swam at the N.C.A.A. Championships each year and scored for her school. A twelvetime All-American, Sheila was awarded an N.C.A.A. postgraduate scholarship as well as a South East Conference (S.E.C.) postgraduate scholarship. She was the recipient of the "Jasper Dorsey Award" as the outstanding senior student at the University.

Twice a G.T.E. scholar, Sheila also was selected as one of the 10 National Finalists in the first "Hanes Her Way N.C.A.A. Woman of the Year" awards, winning a \$10,000 gift in her name to the University of Georgia. She completed her M.B.A. at Georgia in 1994, again Magna Cum Laude (G.P.A. 3.8) - swimming through it all-twice representing the U.S.A. as a National Team Member at the World University Games.

Sheila's dedication to swimming began 'on the steps at Burton Hollow Swim Club.

At five years old, Sheila began competing for the Livonia Family Y Blue Racers. From there, she me a member of United States Swimming and swam with Spartan Aquatic for a short period, finally joining Clarenceville Swim Club where she has been coached by Livonian Greg Phill for almost 15 years.

Under Phill's coaching, Sheila won the 200 meter freestyle at the U.S. Open meet in Auburn, Alabama this past December 1995. Placing second in the 400 meter freestyle at the Open, her time of 4:13:03 currently ranks her ninth in the world in that event.

Sheila has been a Junior National Champion in both the 200 and 400 yard Individual Medley (1985), a Senior National Champion in the 400 meter Individual Medley (1991), a Silver Medalist for the United States at the World University Games in Sheffield, England (1991), and a member of the Gold Medal 800

Free Relay in Fukuoka, Japan (1995), which set a new World University Games World Record. As a member of United States Master Swimming, Sheila holds eleven world records in the 25 to 29 year old age group.

Sheila's motivational address to the High School students talked about the importance of staying "focused" on your goals. She talked about being slotted in an adjoining lane during the Olympic tryouts to Janet Evans, who was expected to take all the awards and medals. Yet by staying focused on her own goals, and not being concerned about Janet's presence, she was able to succeed.

Her message of inspiration was beneficial to the students. "I will remember Sheila's talk as I meet my own challenges after graduation," commented one Senior. Thanks to the Athletic Department and Denny Steele for bringing Sheila to Manchester!

Fire Department Receives Gift To Purchase Rescue Vehicle

that our fire/rescue squad does. "They've been out to my house six or seven times over the past several years," said Dick. "Once for my wife, Eileen, and several times for me. I have severe bronchial asthma and they have sure helped me through some times when I was unable to breathe." He has supported the firemen's fund raising efforts in the past, on a smaller scale, and this opportunity provided him with a reason to assist them in a larger way.

Fire Chief Gary Wiedmayer has had a close relationship with Disbrow for many years. A couple of years ago, Dick asked Gary about donating some shares of GM stock in a similar situation. But the Firefighters Association was not yet a taxexempt organization and the

donation would not have been beneficial to either side at that time. The necessary paper work was filed with the state, and when the Comerica stock doubled, Dick knew that the time was right to make a substantial donation to the department.

"The firemen needed a new rescue truck and they would have to do a major fund raising effort to purchase it," noted Dick. "I hope that this will help them to get matching funds from a grant, as well as maybe encourage others to give larger donations."

Dutchmen Fire Fighters Association President Keith Johnson, estimates the cost of a new rescue vehicle to be about \$130,000. "This would not be just a modified van," he adds, "but a more suitable vehicle for rescue operations. Hopefully, it will be a

complement to the new fire truck and last just as long."

The value of the Comerica stock is estimated to be between \$35,000 and \$40,000, which gives the Fire Fighters Association a major boost in their goal of \$65,000 toward purchase of the rescue equipment. Their hopes are that raising half of the cost of the vehicle will make them eligible for matching funds from a local foundaion.

Eileen Disbrow is a life long resident of Manchester Township. In 1995, the homestead on which they live was designated as a Centennial Farm, although the family has actually lived on the Ely Road farm for over 150 years. Dick grew up in Wauseon, Ohio, and in Brooklyn, Michigan. They married in 1955 after meeting at Ford Motor Company. The Disbrows are both Ford

retirees. After 37 years with Ford, Dick retired in 1980. And two years later, Eileen retired after 35 years of service. In addition, Dick has been successfully investing in real estate since the age of 18. "I wouldn't say we have a lot of money, but we have sufficient money," he says modestly.

"This is an unbelievable gift," said Gary Wiedmayer, speaking on behalf of the fire department. "It will really help in our efforts to purchase the rescue truck much sooner than any of us had anticipated."


