School Board Plans **Town Meeting**

To Discuss Future of our Schools'

Bus Inspection "So-So," says Superintendent

A surprise bus inspection last week, conducted by the State Police post in Jackson, resulted in nine red-tagged buses and one yellow-tagged bus for Manchester Community Schools. Brian Martin of the Motor Carrier Division performed the inspections.

According to Niedzwiecki, "We fared so-so," on this inspection. Several of the red-tagged items were as simple to fix as the buzzers on emergency doors. Any safety-related violation automatically results in a red tag.

"A couple of brake problems involved two buses with brakes out of adjustment," reported Niedzwiecki, and one with a caliper problem. Rumors claimed that brake problems were rampant on several buses, and some brake pads were completely worn down. These rumors were not accurate, according to the information on the inspection reports.

Four buses whose frame rails had previously been repaired, were cracked and needed welding.

The school will work on their pre-trip inspections and preventive maintenance, says Niedzwiecki. A decision to hire a new bus mechanic has not been made, as the school explores future needs within the transportation depart-

Results are still incomplete from the June bus inspections, and the superintendent assures us he is still following up on this matter.



Building A Healthy Community

On Wednesday, October 29, 72 people attended the Tenth Annual Benefit Banauet for the Community Resource Center at Chelsea Community Hospital. The theme was BUILDING A HEALTHY COMMUNITY. Rev. Bob Macfarlane served as Master of Ceremonies. He shared his joy about being asked to return to Manchester to celebrate the successes of the Community Resource Center (CRC).

Rev. Macfarlane was the chairman of the committee which organized the agency to assist dislocated workers after the closing of Double A Products Co. David Little and Dick Kuntz, also a part of that committee, have served on the CRC Board for ten years. Dick, who served as treasurer for most of the ten years, retired in March of 1997 and was given a plaque for his outstanding service and a gift of honorary membership on the CRC Board of Directors.

Dianne Schwab, Director of the Community Resource Center, was presented an award in recognition of her ten years as Director of the Community Resource Center.

The program for the evening was CRC: Past and Present. Dick and Dave discussed their roles as members of a group of 52 Manchester and County residents who were instrumental in making the Center a reality.

The unemployed and low-income people have been a priority for focus of service for the CRC. However, two other programs are examples of programs that target additional populations in the community at the present time.

George Patak, member of the Coalition for Drug Free Youth discussed the mission/ goal of the coalition and the strategies being used to accomplish its goal. Pat Parr, employee of Chelsea Community Hospital and a local resident explained the priorities identified for the Manchester Coalition for Health, a local group organized as part of the Washtenaw County Health Improvement Plan to improve the health in Washtenaw County residents.

Linda Mussio, CRC Board Member, presented nine certificates to volunteers nominated by community orfor their community service.

Dear Editor,

I would like to praise the students of the Manchester Alternative School for their fine citizenship exhibited in several ways on the afternoon of October 31, 1997.

For Halloween, the entire MAS student body was involved in assisting at parties and events in the Manchester schools. Some were assigned to help at Klager Elementary parties, and others were involved in taking photos of costumes at the Middle School.

While traveling Manchester from the Pleasant Lake School, five of the students witnessed a dramatic car accident on Pleasant Lake Rd. An oncoming vehicle apparently lost control, became airborne, and ultimately landed upside down in the westbound lane in front of them. The five students pulled over and quickly went into action. Boyce Jones went across the road to the nearest house and called 911 to report the accident. Brian Klepi, William Batalucco, and Cameron Lehr assisted the two victims from their vehicle. Brian then directed traffic around the overturned car. Rachel Vanover assisted the most seriously injured victim as he lay on the ground awaiting the arrival of EMS.

I happened upon the accident scene at this point (traveling from Pleasant Lake School to a Klager Halloween party myself). Seeing that a victim was lying along side the road, I stopped to offer Nursing/First Aid assistance. The Manchester teens were very calm, and had the scene well under control. Once the first EMS personnel arrived, I departed.

About an hour later, I encountered the MAS teacher, Kathy MacKercher in my son's third grade classroom. She was looking in on one of her students, Deanna, who came to assist with our party activities. From Kathy I learned that once her students had given their statement about the accident to the authorities at the scene, they proceeded on to the Manchester schools as planned.

I am so impressed with these teens. They remained calm, took appropriate emergency action, stayed at the scene, and still followed up with their prior obligations at Klager and the Middle School for the



NOTICE OF PUBLIC HEARING

Notice is hereby given that the Village of Manchester, Michigan, will hold a public hearing on the proposed Village of Manchester Draft Project Plan for improvements to the existing water system. The hearing will be held at 7:30 PM on Monday, December 15, 1997 at the Village offices, 120 South Clinton, Manchester, Michigan 48158.

The purpose of this hearing is to receive comments and views of interested persons on the Draft Project Plan and the environmental impacts of the proposed water system alternatives. The hearing is a requirement of the Michigan Drinking Water State Revolving Fund (DWRF) loan program, from which the Village of Manchester is pursuing project funding.

The recommended plan includes the construction of the following elements:

-Construct approximately 400 feet of 12-inch water main, from Macomb Street extending north across the River Raisin to Riverbend Street providing a second source to the residents of the north service area.

-Replace approximately 850 feet of deteriorating 4-inch water main along Hibbard Street between Duncan Street and City Road (M-52).

-Replace approximately 600 feet of undersized (2-inch) water main with 8-inch water main along M-52 north of Mound Street.

-Construct approximately 800 feet of 12-inch water main along Sooten Road to the existing Village Industrial Park as a second source of water for the purpose of system reliability.

-Construct approximately 600 feet of 12-inch water main along M-52 from Johnson Controls to SGF, as a second source for the purpose of system reliability.

-Construct a loop of approximately 400 feet from the water main on Macomb Street at the railroad track to the water main dead end on Union Street.

-Construct a loop of approximately 600 feet from the water main at the intersection of Territorial Street and Elton Street to the water main dead end on Schaffer Court.

-Construct a loop of approximately 2,400 feet from the water main at M-52, extending east to the Manchester Woods development.

-Replace 10 inoperable water valves located throughout the water distribution system.

-Construct a hydrant at the westernmost end of the existing water main on West Main Street.

-Construct a new 60,000 gallon backwash detention tank at the water treatment facility.

The opinion of probable cost of the proposed project is \$720,000. The estimated costs to a typical residential customer is not expected to be increased, due to available resources included in the existing Village of Manchester Millage.

Copies of the plan detailing the proposed project will be available for public inspection 30 days prior to the hearing at the Village offices, 120 South Clinton, Manchester, Michigan

Leaves In Road Present Dangers

Just a friendly reminder, those wishing to dispose of their leaves are to place them at the edge of the roadway, not in the street. Local, as well as state, laws prohibit placing objects (including leaves) on the roadway which may cause a traffic hazard. Additionally, leaves which are not picked up become the property owners responsibility for removal. Failure to do so may result in a citation being issued for the violation.

The leaves on the roadway pose some major concerns; 1) when wet, the leaves present a problem for vehicles operating on the roadway, 2) the leaves are a potential fire hazard for those who park their vehicles on or near the leaves, 3) the leaves block catch basins, posing potential flooding problems in the area, and 4) children have been seen playing in the leaves, causing an extremely dangerous situation.

For those of you who have raked your leaves, please make sure they are not on the road. If you haven't raked yet, I hope this explains our concerns. 




All in all, the evening went very smoothly and the new, larger facility made everyone more comfortable.

1995 Adoption Law Allows Birth Family Members To Reunite

Adoptees and their birth parents have an effective, but little known, option that enables them to be reunited. Even though a new state law was created in 1995 allowing adult birth family members to petition the court to search for and locate their birth parents, adult birth siblings, or adult adopted child, surprisingly few people know about the law change.

The law, introduced by Senator Bouchard, reflects the understanding of lawmakers that birth family members desire to locate each other with the assistance of the court. This law requires courts to appoint a confidential intermediary to review the closed file, search for the individual and to contact the individual discreetly and confidentially to ascertain whether the individual is willing to release information, or to meet or communicate with the former family member. It also allows the release of identifying information in the event the former family member is deceased. The Michigan Probate Judges Association has sponsored training that most judges require in order to be eligible for appointment as a confidential intermediary.

Annette Zsenyuk, a Confidential Intermediary serv-

ing Michigan courts, said "Many birth family members are not aware of how effective this new law is. By the time I speak with them, many have searched on their own for years. I am usually able to locate their family member within one week or so. Many who do know of the change are not sure whom to contact because they are not sure where they were adopted." She advises adoptees to check with the probate court in the county where their adoptive parents lived at the time the adoption took place; while birth parents can ask the agency that they worked with at the

The law is a good one in that it allows birth family members who wish to be reunited to make contact, and it also requires respect for privacy. To the credit of those who do not wish to communicate, they are almost always willing to exchange photographs and medical history.

Zsenyuk said that birth family members, although surprised at the contact from her, have many immediate questions. "It's evident that these families have been in pain for years. The birth parents always wondered if their child was safe and had a happy life, the adoptees want

to know about their heritage and their medical history. It's gratifying to bring peace of mind to so many people."

Zsenyuk says that she has been able to locate at least one former family member in 100% of her cases, and a whopping 98% agree to some form of contact with their family member. She believes it's especially important for confidential intermediaries to have a strong respect for all parties to the adoption.


Confidential Intermediaries must sometimes be creative in helping birth family

members. "I have arranged for post office boxes and provided telephone calls for adoptees or birth parents to allow privacy when one is not ready or able to share their interest in their former family member with their spouse or adoptive parents. Although I encourage everyone to be honest with their loved ones, I also recognize that is not always possible. I want to serve birth families in whatever way I can to make this experience a positive one."







Why Use BAND AIDS?

Assistive Technology, Part I

What is assistive technology and what does it have to do with band-aids?

- Assistive technology is best defined as an aid which allows you to do something independently. Our world is full of assistive technology. Everyone uses assistive technology. We all see 'gadgets' from time to time that were designed to aid us with some task.
- Band-aids, on the other hand, are a way to cover things up, to make them seem better. They don't fix anything. In most cases they are a temporary thing. Almost every three year old needs a band-aid for every bump and scratch they get. By the time the same child is eight, they don't want a band-aid for even a serious abrasion. If it doesn't fix it they don't want it.

Here are some examples of assistive technology that has been an enormous aid to some people. These items have changed peoples lives, made them more independent, made them feel good about themselves.

Braille - is used by the blind to read printed material. Most kids are introduced to Braille in elementary school. They receive little cards showing how Braille works. Even I am fascinated at how people can learn to run their fingers over the different constellation of bumps and "read". There are now scanners, that can scan a book and translate it quickly to Braille (go to the Washtenaw Library for the Blind to see these for yourself). The bandaid for a blind person would be to have a person read to them. Turning text into Braille is the assistive technology to allow them to read it to themselves.


Closed-captions - is used by the deaf to watch and "hear" television programs and movies on video tapes. A couple a years ago, we got a new TV with closed-captions capabilities. I often turn it on for a serious movie and news broadcast so that I can hear and see what is being said. Almost all programs and movies are available on closed-caption. The band-aid for the deaf is to have a person sign what is being said. Turning words into text is the assistive technology to allow them to hear for themselves.

Chair-lift - is used by people with physical disabilities which require them to be in wheel chairs. These lifts work on vehicles so that people can get from the vehicle to the ground without having to get in and out of their chairs. The band-aid would be to have a person as they are coming and going to help them make the transaction. The lifts are the assistive technology to allow them to be independent.

These are examples of assistive technology for disabled people which allow them to be independent. Although these are very important and significantly affect the lives of these people, the percentage of people that need these items is relatively small. 20% of the population suffer from a disability - called learning disabilities.

What assistive technology is available for this huge number of people? Through a series of articles over the next few weeks, we will tell you about some of them - and we will tell you how you can try them out!

Manchester Historical Society to Explore the Local KKK

News of terrorism dominates the headlines, almost on a weekly basis. But the concept, especially in the United States, is nothing new. The first such well known "terrorist" group in the United States, the Ku Klux Klan, started shortly after the American Civil War. Then, there was Michigan's "The Black Legion."

Michael Clinansmith will share his nearly 27 years of research on this local offshoot of the KKK, "The Black Legion," at the November 18 General Membership meeting of the Manchester Historical Society.

The Black Legion struck fear in the hearts of many locals during their brief reign of terror in the 1930s. Secret memberships, group rallies, an intolerance for reform and clandestine nighttime visits were all part of the Legion's activities. The group was a 1920s offshoot of the KKK that had a brief impact in a number of Michigan counties and several surrounding states from the mid-to-late 1930s. Clinansmith said he has copies of several FBI files that show the group also gained some national notoriety as well.

The meeting starts at 7:30 PM and is in the historic Blacksmith Shop on West Main Street in Manchester. The public is invited to attend this and every general membership meeting, the third Tuesday of the month.
